
Engagement Overview

Station 1: Guiding Principles

Common Themes:

- "Sustainability"
- "Modern, enhanced recreation facilities; value and enhance recreational options in the community"
- "Accessibility for all is essential to allow all Shaker residents to enjoy all community assets"
- "Diversity, equity, and inclusion needs to be better defined to elaborate on values and purpose of the terms"

Station 2: Where our facilities are located

- Please reference the location numbers as shown on the graphic. Thinking city-wide, how important are the current facility locations to you? Which locations are most important and why?
 - "The current locations are good"
 - "Very important to have facilities spread through city. Libraries very important."
 - "The schools and the libraries are most important because they are gathering places for people coming together."

- Thinking about where you live in your neighborhood, what types of facilities or spaces (schools, library, city facilities, playgrounds etc.) do you want?
 - "Green space, playgrounds, library, school."
 - "Parks, libraries, a full recreation center with gym facilities"
 - "Community center with indoor pool and workout center. Nice green spaces"
 - "Dog park"

Station 3: How our facilities can be improved- alternative uses

- "Neighborhood recreational & social facilities."
- "Green Space. Public park with lots of trees and recreational space."
- "Could be re-purposed and used as center for senior citizens and social services and some recreational classes for older people."

Station 4: How our facilities can be more equitable and inclusive

- What inequities do you see in the current locations of Shaker facilities (schools, library or city)?
 - "The poorest part of our community is the farthest away from its elementary school."
 - "Lack of free transportation to the high school."
 - "Ability to walk to school is not equal, especially south of chagrin and Van Aken"
 - "Distance from school locations for students of color."

Station 4: How our facilities can be more equitable and inclusive

- How can our community facilities be more equitable?
 - "Each elementary school should have the same spaces and opportunities in each building - after school programs are often only offered in one elementary and not another."
 - "Better transportation or more centralized locations. After hours opportunities for all students."
 - "Making sure that all facilities are of a similar quality and making sure that all members of the community have easy access to common facilities."

 - "Collaborative spaces are important with a variety of settings, classrooms with various spaces."
 - "Flexible space for different kinds of learners, teachers, individuals and groups."
 - "Multiple learning areas within one large space."

- How do you envision our schools in the future?
 - "Use best practices to create facilities that work for all students."
 - "Warm, inviting, fostering collaboration among students, teachers, and community members."
 - "Opportunities to explore different types of technology and arts."

Do you have a preference on the re-organization of the grades?

Example A [PK / K-5 / 6-8 / 9-12]	65%
Example B [PK - 2 / 3-5 / 6-8 / 9-12]	35%

Common Themes:

- "The developmental stages should be considered"
- "I feel the opportunity for collaboration, mentoring and family-centered programming is optimized when K-5 (or even 6, like it used to be) are all together"
- "Experts should determine based on facts and research"

Master Plan Scenario Process

Review and document prevalent concepts and themes from the Client Group and public engagement sessions (Educational Visioning, Round 1 Engagement to date)

Create a series of options that correspond to the public comment – provide unique ideas in different scenarios for discussion

Options are evaluated based on the Guiding Principals and how successful they are in addressing educational and civic goals

Confirmed options from the Client and Leadership Group are presented for further public comment (Round 2 Engagement)

Further refinement and development of the scenarios based on Round 2 Engagement – ITERATIVE PROCESS


