What is 21st Century Learning?

- Spaces to collaborate and work in teams
- Technology is a critical tool

How Can Facilities Promote Equity?

- All residents should have access to state-of-the-art facilities, regardless of where they live
- Everyone should feel part of the school community
- Our schools and community facilities should be welcoming and inclusive to all, including those with physical or learning disabilities



Fiscal Stewardship and Efficiency

- Create a plan that maximizes benefits to the community
- Adjust spaces to population trends
- Reducing the number of buildings creates operational savings
- Transform underutilized facilities; avoid duplication of services
- Identify cost savings through efficient use of facilities

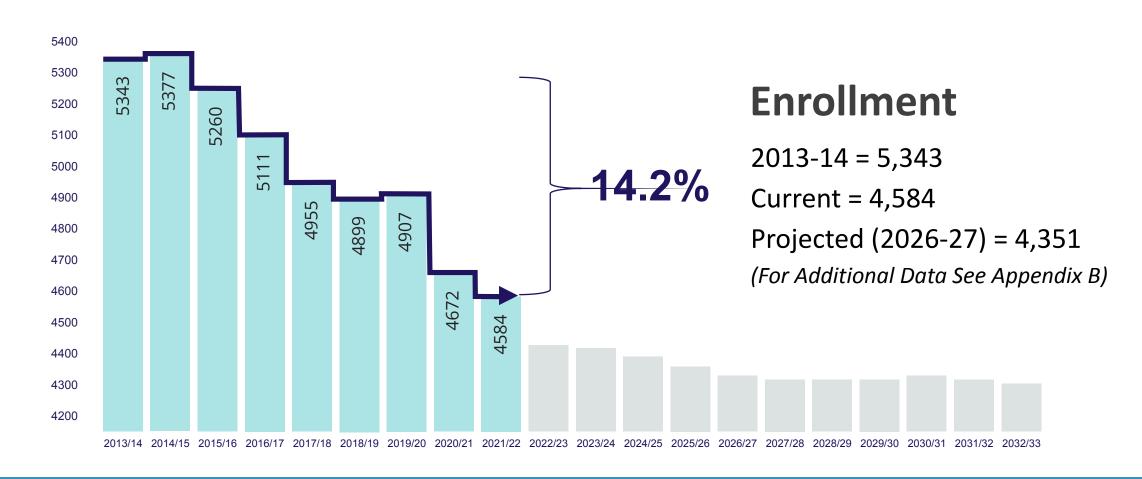


Why Act Now?

- Our current buildings do not meet the needs of our community or our students
- The state funding share for school construction at all-time high
- Declining enrollment trends translate to costly wasted space
- Existing facilities place Shaker at a competitive disadvantage
- Our aging buildings drain resources
- Every year we wait, costs escalate
- Significant capital costs are on the horizon

Key School District Data

- Capacity
 - The present school buildings have a capacity for 6,700 students
 - □ Projected enrollment (2026-27) = 4,351
- Busing
 - 41% of K-4 students are eligible for busing
 - ☐ 71% are Black



Community Engagement

- Round One
 - ☐ Took place October 6-31
 - ☐ Two virtual sessions, three in-person sessions, online questionnaire
 - ☐ More than 7,091 pieces of input from 719 individuals

What Are Concepts?

- Broad ideas created for discussion purposes
- Discussion of concepts will guide development of specific options
- Concepts are based on input from:
 - Advisory Committee
 - Educational Visioning
 - Round One community input
 - Forward Together client and leadership groups



Concept A: Schools (Centralized)

- One new building for all K-5 students at current middle school site
 - Boulevard, Mercer available for adaptive reuse
 - Fernway, Lomond available for possible use for PreK and/or school offices
- One new 6-8 building at current Onaway/Woodbury site
- One new high school at current site, includes Innovative Center (IC)
- One competition-grade indoor pool with shared use
- Relocated Lee Road Bus Depot / Garage (location TBD)

Concept A: City (Decentralized)

- Thornton Park
 - Ice rink relocated to current middle school site
 - Enhance outdoor pool, park/green space
- Recreation
 - Current middle school site
 - Indoor recreation center and/or outdoor recreation facilities
- Senior Wellness and Youth Activities Center
 - At renovated Stephanie Tubbs Jones Community Building
 - Outdoor amenities (e.g. basketball)



Concept A: Library

- Bertram Woods Branch Library
 - Renovate and part of middle school site campus
 - Alternate: Combine with recreation center if pursued in future
 - Consider closure of Fayette Road
- Main Library Renovation
 - Renovation completed in 2021
 - Home to the new Schools Welcome Center



Concept B: Schools (Decentralized)

- Renovate or build new Boulevard, Lomond, Mercer for K-4 students
- Fernway remains K-4 school
- New 5-8 building at current Onaway/Woodbury site
- One new high school at current site, includes Innovative Center (IC)
- PreK located in K-4 buildings (location TBD)
- One competition-grade indoor pool with shared use
- Relocated Lee Road Bus Depot / Garage (location TBD)

Concept B: City (Centralized)

- Thornton Park
 - Available for redevelopment/green space
- Recreation
 - Current middle school site
 - Indoor recreation center and/or outdoor recreation facilities
 - New ice rink, outdoor pool
- Senior Wellness and Youth Activities Center
 - At renovated Stephanie Tubbs Jones Community Building
 - Outdoor amenities (e.g. basketball)

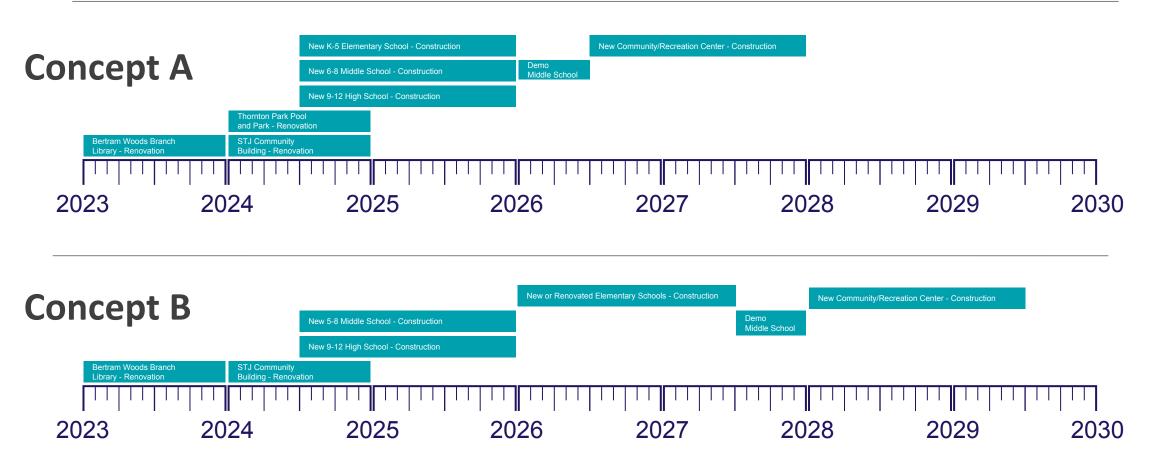


Concept B: Library

- Bertram Woods Branch Library
 - Renovate and part of middle school site campus
 - ☐ Alternate: Combine with recreation center if pursued in future
 - Consider closure of Fayette Road
- Main Library Renovation
 - ☐ Renovation completed in 2021
 - Home to the new Schools Welcome Center



Conceptual Timelines for Cost Estimating





Potential Funding Sources

- Bond issue
- State co-funding for school construction
- Local budgets
- Operational savings
- Other certificates of participation (COPs)



Ohio Facilities Construction Commission (OFCC)

- The State of Ohio provides co-funding for the design and construction of schools
- ☐ The state's share of co-funding is currently 36% of qualifying expenses
- Elements not eligible for OFCC funding are funded by the District as Locally Funded Initiatives (LFIs), i.e. auditoriums, pools, planetariums, etc.



Other Communities

- Warrensville Heights: \$73,888 per student
 - New elementary, middle and high schools
 - Currently under construction
- Cleveland Heights-University Heights: \$73,136 per student
 - Renovated two middle schools and one new high school
 - Completed construction pricing escalated to present value
